Alive After Five is a trademark of the Downtown Boise Association, celebrating its 31<sup>st</sup> year this summer, back on the Grove Plaza! The DBA views the participating restaurants as partners, and wishes to work together with the restaurants in the spirit of teamwork to enhance downtown. Proceeds derived from Alive After Five are used to fund DBA clean, safe and vibrant programs in downtown Boise. All DBA member restaurants in good standing will be eligible to participate in the Alive After Five event. *(please note: restaurants located on the footprint of the event have the option to be open during the event)*

## Guidelines

### Food Booth

There will be ONE food booth slot at each of the 13 Alive After Five events. The event will be held on the Grove Plaza from 5-8pm starting every Wednesday from June 7 – August 30. If more than 13 applications are received, a simple lottery will be used to award the slots. If less than 13 applications are received, then each applicant will have the opportunity to serve additional nights so that the event will have a food booth each week. Any DBA member restaurant in good standing is eligible, and the DBA will oversee assigning restaurants with their date(s).

### Expectations

Due to a new event footprint and space limitations, the following expectations must be met to be eligible to serve at Alive After Five:

**Electricity will not be available;** therefore all food vendors must be self-sufficient.

The restaurants on the footprint of the event have the option to be open and sell food during the event from within their business.

**NO Generators will be allowed.**

**No Beverage Sales of any kind. (including non-alcoholic beverages)**

**Load in and load out will need to be approved by the DBA event staff no less than 1 week before your scheduled date.**

**Restaurants will need to apply with the health department on their own, prior to the scheduled event date.**

**Restaurants are responsible for carrying their own permits & passing their own inspections.**

DBA will provide (1) 10x10 canopy, (2) 6 foot tables, (1) hand wash station and (1) bar counter to sell from- **everything else needed you are required to bring.**

**Participating restaurants will keep all revenues from their food sales and will provide their own cash bank.**

Again, thanks to Food Services of America there is **NO FEE** for participation in the event.

We do ask however that every participating restaurant bring a banner of some type to promote their business.
